10. Discuss and consider the following:

A) TWDB Reserve Account

Kris reported that the bank had confirmed the penalty for redeeming a CD prior to its expiration date was the forfeiture of 1 month's interest and earned interest can be swept monthly into an account of our choice. Currently LPPAWSC must maintain three (3) accounts to guarantee three (3) different loans. Of these accounts one is a NOW account, one is a noninterest-bearing account, and one is a CD. The board discussed investing non-CD accounts into CD accounts and whether to reinvest the monthly interest payments into the CD or whether to sweep the interest into a different account. The auditor had recommended sweeping the interest into a separate account to keep it separate from the principle. Harry Romine will verify the Auditor's recommendation and learn why she recommended that action rather than reinvesting it into the CD.

B) BCBS Renewal Quotes

Discussed employee health insurance benefits and the premium increased. No action is being taken at this time as LPPAWSC will continue with existing policy; however, during the next budgeting cycle the Personnel and Finance Committees will consider and evaluate any potential changes and include associated costs in the next year's budget.
