A report and discussion followed by the Plant Infrastructure and Finance Committee. Bruce and Chase spoke about the funds available to our corporation. Our ranking among the other similar water corporations licensed in the state is quite high so we could probably qualify for what we ask for. The repayment of these funds affects our base water bill which some consider is already high. We have spent a lot on our physical plant and that is in good

shape now so we need to attend to some supply line improvements. The Budget Committee will work on this list this last quarter.

The Personnel Policy Review was given by Laura. Our Attorney has sent back version 4 which has many changes which are necessary for our type of business and the world we live in today. We had a good Board discussion involving spending limits and changes involved in switching to Direct Deposit. The few questions we have will go back to the attorney for review and the final document should be ready for Board approval next meeting.

Public Comments: Mr. Paul Koonsman spoke and said," We have spent a lot of money for all this these plant improvements. I asked the engineer how much more these improvements would increase our capacity. He didn't really give me a straight answer but said about 10% to 15% more capacity. I thought we would get a little better increase than that." Chase gave a rundown on the difficult way the State of Texas calculates system capacity. The important numbers are that in a perfect world we could have about 915 connections and we have 671 now. Chase says he is not qualified to say whether the guy Paul spoke to was accurate but the engineer with the same firm that he is dealing with now is much easier to understand than the original engineer. Chase did not feel that lack of water capacity would be a problem in the near future.
