- B. Annual Meeting: Meeting will be held at the Lake Palo Pinto Volunteer Fire Department office at 7830 FM 2692, Gordon, TX 76453 on March 11, 2023 at 10:30 AM. The agenda was reviewed and the new board might wait until the regular board meeting on March 13, 2023 to make assignments.
- C. CDBG Update: There is minimal cooperation from Palo Pinto County. Phone calls are not returned and questions are not being answered. If this keeps up we will miss some important deadline and be eliminated from the process. We are willing to do everything necessary to make this process work, but there are requirements the county must meet. The Texas State Legislature needs to allow public corporations to apply for block grant money directly without going through a municipality.
- D. Employee Uniforms and Footwear: The board is receptive to furnishing uniforms. Subscription services are expensive in this remote area. Chase has some ideas and will make further recommendations before board action.
- E. Request for Leak Review: Mr. Kerr submitted a request for a break on his water bill last November. This matter was brought before the board because the paperwork submitted was not complete. A repair invoice must be submitted with the application stating materials, labor and compensation. Photos without explanation are not acceptable. Mr. Kerr can reapply.
